and otherwise in accordance with all other laws and regulations and rules of the SGX-ST or, as the case may be, Other Exchange, as may for the time being be applicable, be and is hereby authorised and approved generally and unconditionally (the "**Share Purchase Mandate**");

- (b) unless varied or revoked by the Company in general meeting, the authority conferred on the directors pursuant to the Share Purchase Mandate may be exercised by the directors at any time and from time to time during the period commencing from the date of the passing of this Resolution and expiring on the earliest of:
 - (i) the date on which the next Annual General Meeting of the Company is held;
 - (ii) the date by which the next Annual General Meeting of the Company is required by law to be held; and
 - (iii) the date on which purchases and acquisitions of Shares pursuant to the Share Purchase Mandate are carried out to the full extent mandated;
- (c) in this Resolution:

"**Average Closing Price**" means the average of the last dealt prices of a Share for the five consecutive market days on which the Shares are transacted on the SGX-ST or, as the case may be, the Other Exchange, immediately preceding the date of the market purchase by the Company or, as the case may be, the date of the making of the offer pursuant to the off-market purchase, and deemed to be adjusted in accordance with the listing rules of the SGX-ST for any corporate action which occurs during the relevant five-day period and the date of the market purchase by the Company or, as the case may be, the date of the making of the offer pursuant to the off-market purchase;

"**date of the making of the offer**" means the date on which the Company makes an offer for the purchase or acquisition of Shares from holders of Shares, stating therein the relevant terms of the equal access scheme for effecting the off-market purchase;

"**Maximum Limit**" means that number of issued Shares representing 2% of the total number of issued Shares as at the date of the passing of this Resolution (excluding treasury shares and subsidiary holdings (as defined in the Listing Manual of the SGX-ST)); and

"**Maximum Price**", in relation to a Share to be purchased or acquired, means the purchase price (excluding brokerage, commission, applicable goods and services tax and other related expenses) which shall not exceed, whether pursuant to a market purchase or an off-market purchase, 105% of the Average Closing Price of the Shares; and

- (d) the directors and/or any of them be and are hereby authorised to complete and do all such acts and things (including executing all such documents as may be required) as they and/or he may consider expedient or necessary or in the interests of the Company to give effect to the transactions contemplated and/or authorised by this Resolution.

EXPLANATORY NOTES:

Resolutions 2, 3 and 4 – Detailed information on these directors can be found under the Board of Directors, Corporate Governance Report and Supplementary Information sections in the Annual Report 2020.

Resolution 2 – Resolution 2 is to approve the re-election of Tan Sri Mohd Hassan Marican, who will retire under article 94 of the Company's Constitution, as a director of the Company. Upon re-election, Tan Sri will remain as the Chairman of the board of directors and the Executive Committee, and a member of the Nominating Committee, the Executive Resource & Compensation Committee and the Special Committee. He is considered a non-independent and non-executive director.

Resolution 3 – Resolution 3 is to approve the re-election of Mr Bob Tan Beng Hai, who will retire under article 94 of the Company's Constitution, as a director of the Company. Upon re-election, Mr Tan will remain as the Chairman of the Board Risk Committee and the Special Committee and a member of the Executive Committee. He is considered an independent director.

Resolution 4 – Resolution 4 is to approve the re-election of Mr William Tan Seng Koon, who will retire under article 94 of the Company's Constitution, as a director of the Company. Upon re-election, Mr Tan will remain as a member of the Executive Committee, the Audit Committee and the Executive Resource & Compensation Committee. He is considered an independent director.

Resolution 5 – Resolution 5 is to approve the payment of an aggregate amount of S\$1,800,000 as directors' fees for the non-executive directors of the Company for the year ending 31 December 2021. The amount of directors' fees is computed based on the anticipated number of board and committee meetings for year 2021, assuming full attendance by all of the non-executive directors. In the event that the amount proposed is insufficient, approval will be sought at the next Annual General Meeting in year 2022 ("**2022 AGM**") before payments are made to directors for the shortfall. Directors and their associates will abstain from voting on Resolution 5. The Chairman of the Meeting will accept appointment as proxy for any other shareholder to vote in respect of Resolution 5, where such shareholder has given specific instructions in a validly completed and submitted proxy form as to voting, or abstentions from voting, in respect of Resolution 5.

The amount of directors' fees approved at the Annual General Meeting in year 2020 was S\$2,000,000. The total amount of directors' fees paid to the directors in year 2020 was S\$1,736,475, full details of which can be found on page 208 of the Annual Report 2020.

The current intention is that (save for Mr Koh Chiap Khiong) the directors' fees for the non-executive directors for year 2021 will comprise a cash component and a share component, with up to 30% being delivered in the form of restricted share awards under the Sembcorp Marine Restricted Share Plan 2020. Any such award would typically consist of the grant of fully paid shares outright with no performance or vesting conditions attached, but with a selling moratorium. Under the directors' fee framework (which is set out on pages 56 and 57 of the Annual Report 2020), non-executive directors are required to hold shares (including shares obtained by other means) worth at least the value of their basic retainer fee of S\$75,000; any excess may be disposed of as desired. A non-executive director can dispose of all of his shares one year after leaving the Board. The director's fee due to Mr Koh, who holds an executive position in Sembcorp Industries Ltd ("**SCI**"), will be paid wholly in cash to SCI.

The cash component of the directors' fees for year 2021 is intended to be paid half-yearly in arrears. The share component of the directors' fees for year 2021 is intended to be delivered after the 2022 AGM has been held. The actual number of shares to be awarded to each non-executive director holding office at the time of the payment is intended to be determined by reference to the volume-weighted average price of a share on the Singapore Exchange Securities Trading Limited (the "**SGX-ST**") over the 14 trading days from (and including) the day on which the shares are first quoted ex-dividend after the 2022 AGM (or, if no final dividend is proposed at the 2022 AGM, or the resolution to approve any such final dividend is not approved at the 2022 AGM, over the 14 trading days immediately following the date of the 2022 AGM). The number of shares to be awarded will be rounded down to the nearest hundred and any residual balance will be settled in cash. A non-executive director who steps down before the delivery of the share component will receive all of his directors' fees for year 2021 (calculated on a pro-rated basis, where applicable) in cash.

Resolution 7 – Resolution 7 is to empower the directors to issue shares of the Company and to make or grant Instruments (such as warrants or debentures) convertible into shares, and to issue shares in pursuance of such Instruments, up to a number not exceeding 50% of the total number of issued shares of the Company (excluding treasury shares and subsidiary holdings), of which up to 5% may be issued other than on a pro rata basis to shareholders. The aggregate number of shares which may be issued shall be based on the total number of issued shares of the Company (excluding treasury shares and subsidiary holdings) at the time that Resolution 7 is passed, after adjusting for (a) new shares arising from the conversion or exercise of any convertible securities or share options or vesting of share awards which were issued and are outstanding or subsisting at the time that Resolution 7 is passed, and (b) any subsequent bonus issue or consolidation or subdivision of shares. As at 9 March 2021 (the “**Latest Practicable Date**”), the Company had 416,840 treasury shares and no subsidiary holdings.

Resolution 8 – Resolution 8 is to empower the directors to offer and grant awards pursuant to the Sembcorp Marine Performance Share Plan 2020 and the Sembcorp Marine Restricted Share Plan 2020 (collectively, the “**Share Plans**”) and to issue ordinary shares of the Company pursuant to the vesting of awards granted pursuant to the Share Plans provided that: (a) the aggregate number of (i) new ordinary shares allotted and issued and/or to be allotted and issued, (ii) existing ordinary shares (including shares held in treasury) delivered and/or to be delivered, and (iii) ordinary shares released and/or to be released in the form of cash in lieu of ordinary shares, pursuant to the Share Plans shall not exceed 5% of the total number of issued ordinary shares of the Company (excluding treasury shares and subsidiary holdings) from time to time; and (b) the aggregate number of ordinary shares under awards to be granted pursuant to the Share Plans during the period commencing from this Annual General Meeting to the next Annual General Meeting shall not exceed 0.5% of the total number of issued ordinary shares of the Company (excluding treasury shares and subsidiary holdings) from time to time.

Resolution 9 – Resolution 9 is to renew the mandate to enable the Company, its subsidiaries and associated companies that are entities at risk (as that term is used in Chapter 9 of the Listing Manual of the SGX-ST), or any of them, to enter into certain interested person transactions with specified classes of interested persons, as described in the Letter to Shareholders dated 31 March 2021 (the “**Letter**”). Please refer to the Letter for more details.

Resolution 10 – Resolution 10 is to renew the mandate to enable the Company to purchase or otherwise acquire issued ordinary shares of the Company, on the terms and subject to the conditions set out in the resolution.

The Company intends to use internal and/or external sources of funds to finance the purchase or acquisition of its ordinary shares. The amount of financing required for the Company to purchase or acquire its ordinary shares, and the impact on the Company’s financial position, cannot be ascertained as at the date of this Notice as these will depend on the number of ordinary shares purchased or acquired, the price at which such ordinary shares were purchased or acquired and whether the ordinary shares purchased or acquired are held in treasury or cancelled.

Based on the existing issued ordinary shares as at the Latest Practicable Date and excluding any ordinary shares held in treasury, the purchase by the Company of 2% of its issued ordinary shares (and disregarding the 416,840 ordinary shares held in treasury) will result in the purchase or acquisition of 251,104,580 ordinary shares.

In the case of both market purchases and off-market purchases by the Company and assuming that the Company purchases or acquires the 251,104,580 ordinary shares at the Maximum Price of S\$0.17 for one ordinary share (being the price equivalent to 105% of the average of the last dealt prices of the ordinary shares for the five consecutive market days on which the ordinary shares were traded on the SGX-ST immediately preceding the Latest Practicable Date), the maximum amount of funds required for the purchase or acquisition of the 251,104,580 ordinary shares is S\$42,687,779.

The financial effects of the purchase or acquisition of such ordinary shares by the Company pursuant to the proposed Share Purchase Mandate on the audited financial statements of the Group and the Company for the financial year ended 31 December 2020 based on these assumptions are set out in paragraph 3.7 of the Letter.
