Temasek is filing this notification form to report a change in deemed interest from 60.98% to 61.09% in the issued voting shares of the Listed Issuer due to the off market purchase of 2,448,900 voting shares by DBS Bank on 31 March 2016.	
The filing of Temasek's deemed interest arises from the aggregation of interests held by Sembcorp Industries Ltd ("SCI"), ST Asset Management Ltd. ("STAM") and DBSH.
